

Daniel McCaffery – Pennsylvania Supreme Court (D)

Daniel McCaffery is a military veteran and an experienced judge who wants “to restore faith in the judicial branch of government.”

He **currently sits on the Pennsylvania Superior Court** and has a strong record of public services and putting everyday folks and working families first.

McCaffery has received the support of many labor unions and both Planned Parenthood of PA and Pennsylvania National Organization for Women. The Pennsylvania Bar Association rates him as **Highly Recommended** citing his “broad experience as a practicing attorney, proven record of judicial leadership, high ethical standards and dedication to the legal profession and the community.”

Dan McCaffery will stand with everyday Pennsylvanians to protect their rights and freedoms, and ensure the courts protect the people, not just the rich and powerful.

Carolyn Carluccio - Pennsylvania Supreme Court (R)

Carolyn Carluccio is currently a Montgomery County judge who receives most of her funding from far right billionaire Jeffery Yass. Carluccio thinks that Act 77, the law that enacted mail-in voting, is bad for Pennsylvania and she would like to change it. She also refuses to say that the 2020 presidential election was legitimate. Carluccio is endorsed by extreme anti-abortion organizations despite erasing anti-abortion language from her website after the primary.

Tamika Lane - Superior Court (D)

Tamika Lane is currently serving on the Court of Common Pleas for Philadelphia County. She believes that everyone who comes before her as a judge deserves to be treated with dignity and respect no matter their background. She is committed to applying the law fairly and to protecting the rights of all Pennsylvanians.

She has worked as a public school teacher, a public defender and she helped protect our right to vote as Chief Legal Counsel for a Pennsylvania State Senator. She is **highly recommended by the Pennsylvania Bar Association** and has the support of organized labor, education advocates, and women’s and reproductive rights organizations.

Jill Beck - Superior Court (D)

Jill Beck is an attorney with a strong history as an advocate for vulnerable communities and those without a voice. She is running for the Pennsylvania Superior Court to uphold the rights of all Pennsylvanians regardless of race, religion, sexual orientation, gender identity, disability, or income.

Jill is **highly recommended by the Pennsylvania Bar Association** and has the support of labor unions, teachers' unions, reproductive rights and women's organizations and progressive advocacy organizations.

Maria C. Battista - Superior Court (R)

Maria Battista has 15+ years of legal experience in civil, criminal, and administrative law and is a former Assistant District Attorney. As a Commonwealth attorney, Battista was counsel in the Departments of Health and State. She was endorsed by the Republican party in the primary election.

Harry F. Smail - Superior Court (R)

Harry Smail was appointed to the Westmoreland County Common Pleas court by former Republican Governor Tom Corbett.

His rulings show pro-gun positions, support for the oil and gas industry's exploitation of our natural resources.

As a judge in 2020 Smail ordered the Westmoreland County Board of Elections to throw out the ballots of 204 voters because the voters followed improper instructions from election workers; no evidence of voter fraud was presented.

Matt Wolf - Commonwealth Court of Pennsylvania (D)

Matt Wolf has been in the United States military for over 20 years and today serves as a Cavalry Scout soldier in the Pennsylvania Army National Guard. He is currently the Supervising Civil Judge of the Philadelphia Municipal Court.

During his time as a judge, Matt Wolf has worked to improve our court system and increase access to justice and fairness for everyone. During the COVID-19 pandemic, he helped create an eviction diversion program which became a national model, helping tens of thousands of people stay in their homes.

Matt has a history of public service and experience standing up for people's rights as a civil rights lawyer, fighting against discrimination based on housing, race, gender, pregnancy and disability. He is rated as Recommended by the Pennsylvania Bar Association.

Megan Martin - Commonwealth Court of Pennsylvania (R)

Megan Martin has deep roots in the Republican party having worked almost exclusively for Republican administrations and Republican elected officials.

She is a self-described "textualist and originalist," in that she believes the Constitution should apply to modern day society just as it did at the time it was written, when women and people of color were not recognized as having Constitutional rights and freedoms.

Martin is endorsed by the PA Pro-Life Federation, an extreme anti-abortion group that works to ban abortion outright with no exceptions and she supports the Supreme Court 2022 decision in *Dobbs* which took away abortion rights that had existed for nearly half a century.
